- Allowance for independent BOD members: 5,000,000 VND/person/month

The above levels are in line with the remuneration plan for the BOD and Supervisory Board approved by the 2023 AGM.

- Total projected remuneration for the Chairman of the BOD, BOD Members, Head of the Supervisory Board, and Supervisory Board Members in 2025: 312,000,000 VND (*Three hundred twelve million dong*).
